



Terms of Service for Schuylkill Move More Month

These Terms of Service ("Terms") govern your participation in the Schuylkill Move More Month Challenge ("Challenge") organized by Schuylkill County's VISION ("Organizer"). By participating in the Challenge, you agree to comply with these Terms and any additional instructions provided by the Organizer. Please read these Terms carefully.

1. Eligibility:

- a. The Challenge is open to individuals of all ages, unless otherwise specified by the Organizer.
- b. Participants under the age of 18 must have parental or guardian consent to participate.

2. Participation:

- a. Each participant must complete the registration process, if required, as specified by the Organizer.
- b. The Challenge may have a limited number of participants. Registration may be on a first-come, first-served basis.
- c. Participants must provide accurate and truthful information during registration and throughout the program.

3. Code of Conduct:

- a. Participants must conduct themselves in a respectful and sportsmanlike manner throughout the Challenge.
- b. Harassment, discrimination, or any form of offensive behavior towards other participants or individuals involved in the Challenge will not be tolerated and may result in disqualification.
- c. Participants must comply with all applicable laws and regulations during the Challenge.

4. Safety:

- a. Participants must prioritize their safety and the safety of others during the Challenge.
- b. Participants should be mindful of their surroundings and exercise caution when completing challenges or exercising.
- c. Participants must follow all applicable traffic rules and laws when navigating public spaces.

5. Intellectual Property:

a. Participants retain ownership of any content they create during the Challenge, such as photos or videos, but grant the Organizer a non-exclusive, royalty-free license to use, reproduce, and distribute the content for promotional purposes related to the Challenge and VISION programs.

b. The Organizer and its affiliates, employees, or representatives shall not be held liable for any injury, loss, or damage arising from or related to the challenge.

b. Participants found to be in violation of these Terms or any instructions provided by the Organizer may be disqualified from the Challenge.

9. Modification of Terms:

a. The Organizer reserves the right to modify these Terms at any time. Participants will be notified of any changes via the official communication channels established by the Organizer.

10. Governing Law:

These Terms shall be governed by and construed in accordance with the laws of Schuylkill County. Any disputes arising from or in connection with these Terms shall be subject to the exclusive jurisdiction of the courts of Schuylkill County.
